Mr. Ingalsbe has contacted the town's attorney Mr. Jeff Graff asking him to research the year that the town of Farmington obtained the Salem Cemetery. The tax survey shows that the cemetery is not in the towns name but is owned by the Salem Cemetery Association, which does not exist.

### **CEMETERY SIGNS:**

Ms. Ingalsbe said that they believe they have found a way to mount the Hathaway Cemetery sign to the post so it's outside the lettering. The angle of the sign will be changed to face the opening of the cemetery.

### **POWER CEMETERY:**

Mr. Jeff Ransco said that he will add some rocks, dirt, and mulch around the sign at Power Cemetery to steady it up.

Ms. Allison said that the sign for the unmarked graves is made and they may add a bench next to it. Ms. Allison has been doing some research on markers to place at the earlier settlers graves. Ms. Allison said that she tried contacting a company called Carrot-Top Industries. She has not getting any response from them.

Ms. Hallings said that she found two possible companies called Bronze Memorials and International Bronze. The members discussed what each company could make and the cost. Bronze Memorial Company has 7 X 5 plaques. The plaque would be placed at a 30 degree angle and can be put on a 24 inch stake. These plaques come with a 100 year guarantee.

Ms. Ingalsbe said that she will speak with Mr. Dave Cooper who owns Dave's Diggs, about markers made from granite.

### **TOWN STRUCTURES:**

Ms. Ingalsbe said that she will ask Mr. Dan Delpriore to inform the Historic Preservation members of any 50+yr structures that are slated to be torn or burned down.

### **COBBLESTONE TOUR:**

Ms. Allison asked the members if they would like to look into doing a driving tour of cobblestone home in Farmington.
